II. GUEST – Nicole Elliot and Jeremy Schwartz, SF Office of Cannibis (OOC)

2005 medical cannabis legalized. 51 businesses. 31 store fronts. 20 délivery only.

Cannabis legalization task forct created w/ Prop 64

OOC created summer 2017. Under city administrators office.

142 temp permits granted to cultivators.

Regulatory control framework:

Dual licensing system: local and state. Apply to OOC, then Land Use, neighborhood outreach, community benefits agreements, odor controls prior to final permit issuance.

Land use control framework

600 feet (~2 blocks) from schools (K-12). Pre-school, youth center, and day care are not included as an immediate denial. However, the Planning

day care are not included as an immediate denial. However, the Plannir Commission will likely included those facilities in their assessment.

Legally, cannabis cannot be consumed in the public.
Creation of "consumption lounges" being discussed.
Michael Christensen at Planning is a good point of contact with any questions.

New establishment will have to go thru the Equity Program.
If eligible then you will be granted an application.
Phase 1: Proof of space, ownership of business, disclosure of all owners, etc.
If you pass thru that phase 1, then your application is forwarded to Planning.
Businesses will need systems in place for security, employment, etc.

30 days notice to community.

Concern raised that historically Planning Commission does not post adequate signage for conditional use changes. Landlords regulate whether tenants can consume on their properties.

Consumption not allowed on any public housing properties.
